The listed Ter Beke NV will henceforth be called What's Cooking Group NV and proudly carries as Ticker on the Euronext stock exchange: WHATS (instead of formerly TERB).

The company is known for its charcuterie, savoury snacks and ready meals such as Come a casa®. The internationally active and family-listed group not only looks back on this rich history: the company is opting for a new chapter with a renewed strategy, a new company name, logo and company names: What's Cooking?

The company wants to respond to current consumer demands and take a leading role in making the food industry more sustainable, both in terms of innovations of existing and new products, packaging, production processes and services to its customers. This will require time and investment, but the resources to do so are already in place to achieve the ambition:" **Day by day we make sustainable food consumption second nature.**" The new name for each company underlines that each country within the group goes to great lengths to create delicious high quality dishes and products for its customers and for consumers.
